1 Briefly describe the organization's mission: Rooted in a history of compassionate service and mutual trust, the Mission seeks to strengthen coastal and island communities from Mid-Coast to Downeast Maine by educating youth, enabling families and promoting healthy lifestyles.

The "EdGE" after school program - children in grades K through twelve are helped to gain the skills they need to succeed as students and to build their character and confidence through multi-site in school, after school and summer programs. The goal is youth development and family support. Approximately 700 students participate annually.

4b (Code: ) (Expenses \$ 838,341. including grants of \$ 43,725.) (Revenue \$ 2,552.) Island Outreach, Health Services and Church Support - pastoral counseling, worship services, recreation activities, fellowship gatherings and middle school student activities are provided to residents of off-shore islands of Mid-Coast and Downeast Maine by the Island Outreach staff. The Outreach staff coordinates the publication of the "Island Reader", an annual collection of writings and art by island residents. The Island Health Services Registered Nurse (RN) and staff provide personal health visitations and access to educational and health screening clinics to island residents. The RN is able to connect island residents with health providers on the mainland thru the use of the Mission's "telemedicine" equipment. The Outreach and Health Services employees are able to (See Schedule O for Continuation)

4c (Code: ) (Expenses \$ 724,872. including grants of \$ ) (Revenue \$ 1,075.) Downeast Campus Community Outreach - People in need in Downeast Maine receive a variety of services operating out of the Downeast Campus in Cherryfield, Maine. Services include: a food pantry that provides approximately 188,650 meals annually, a senior companion program in Washington and Hancock counties, donor-directed fuel assistance, collaboration with visiting church groups to rebuild and weatherize local homes, access to spiritual walking trails and various community-building gatherings and a Christmas Program that distributed approximately 16,500 gifts to 1,500 people on the islands and in coastal communities.
